#### News from our President...Bonnie Eichholtz




Hi Everyone,

#### WHAT YOU NEED:

1 PKG. (3.9 oz) JELL-O Chocolate Instant Pudding 1½ cups of cold milk 1 tub (8 oz) COOL WHIP whipped topping, thawed, divided

1 tub (8 oz) COOL WHIP whipped topping, thawed, divided 16 Oreo Cookies, coarsely crushed (about 1  $\frac{1}{2}$  cup, divided 1  $\frac{1}{2}$  cups cherry pie filling (21 oz can)

Beat pudding mix and cold milk in medium bowl with wisk for 2 minutes. Stir in 1 cup of the COOL WHIP.
