1 REFRIGERATED PIE CRUST 1 LIGHTLY BEATEN EGG WHITE 1 CAN APPLE PIE FILLING CINNAMON SUGAR CARAMEL SAUCE (IF YOU WANT, THE TYPE YOU PUT ON ICE CREAM) BROKEN WALNUTS IF YOU WANT



ONE REFRIGERATED PIE CRUST (I USE PILLSBURY) PREPARE CRUST AS DIRECTED ON PACKAGE. PLACE ON PARCHMENT PAPER ON ROUND PIZZA TIN, OR COOKIE SHEET PRESS OUT ANY FOLDS OR CREASES IF NEEDED. BRUSH CRUST WITH LIGHTLY BEATEN EGG WHITE

IN CENTER OF PIE CRUST EMPTY APPLE PIE FILLING - BE SURE YOU LEAVE SPACE AROUND PIE CRUST TO FOLD UP OVER PIE FILLING, ABOUT 1 INCH OR MORE

SPRINKLE WITH NUTS AND MIX A LITTLE. DRIZZLE CARAMEL SAUCE OVER PIE FILLING IF YOU WANT. FOLD CRUST OVER APPLES ABOUT AN INCH AND FOLD AS YOU GO AROUND PIE CRUST. BE SURE TO BRUSH EGG WHITE ON CRUST YOU HAVE FOLDED SO IT DOES NOT UNFOLD. SPRINKLE IT ALL WITH CINNAMON SUGAR


