September 9, 2019 – Board Meeting at Bonnie's House

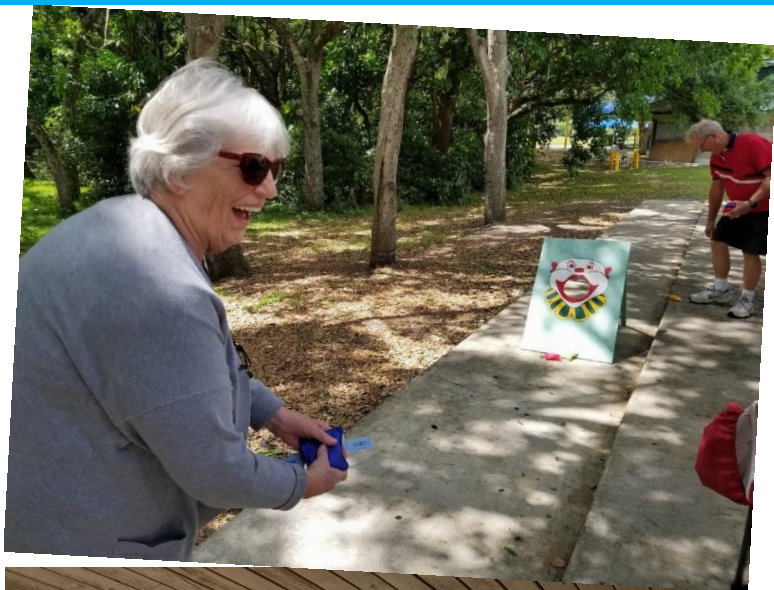
